

HIMACHAL PRADESH JAL SHAKTI VIBHAG RECRUITMENT NOTICE

Applications are invited from eligible candidates for the following posts purely on part time/hourly basis for operation and maintenance of Water Supply /Irrigation Schemes under Jal Shakti Division, Dharampur Distt. Solan H.P. which are revised allocated by the Engineer-in-Chief, Jal Shakti Vibhag Shimla letter No. JSV-ES-III-D.W.-Manpower Vol-VII/2023-2452-56 dated 27.08.2024 which further communicated by the Superintending Engineer, Jal Shakti Circle, Solan letter No. 3700-04 dated 29.08.2024. The application form neatly typed/handwritten in English/Hindi along with attested/self-attested copies of relevant supporting documents should reach in the office of the Executive Engineer, Jal Shakti Division, Dharampur Distt. Solan H.P. on or before 20.08.2025 upto 5:00 P.M. The applications received after last date or found incomplete will be rejected. The post shall be increased/decreased at any time. Initial merit based on the experience and qualification of candidate shall be drawn as per criteria notified and top most eligible candidates (at least 5 times to vacancies) will be called for physical test. Separate call letters will be issued to the candidates for the same. The applicants should mention their phone No. (if any) in the application form. No TA/DA will be payable to the applicants for appearing in physical test.

Note:- The selected candidates shall be deputed under the jurisdiction of Jal Shakti Division, Dharampur (i.e. under Jal Shakti Section, Dharampur, Garkhal, Kumarhatti, Subhathu, Deothi, Parwanoo & Banasar).

DOCUMENTS TO BE ATTACHED WITH APPLICATION:-

The attested/self-attested copies of the following documents are required to be attached with the application form.

1. MULTIPURPOSE WORKERS.

- Bonafide Himachali certificate.
- Middle (8th class) certificate showing detail of marks obtained.
- Proof of age.
- ST Certificate issued by competent authority as per HP Govt time to time notifications.
- Experience certificate as described below.
- Character Certificate issued by 1st Class Magistrate.

MODE OF SELECTION:-

The total selection process is of 10 marks with following distribution of marks:- Criteria	Multipurpose workers

NOTE:- The detail of physical test shall be as under:-

A) Physical Test:-

- (1) He/She should be capable to carry tools and pipes in hilly areas.
- (2) He/She should have no t any physical disabilities and color blindness.

TERMS & CONDITIONS OF SERVICE

- (1) The selected incumbent will be paid honorarium @ of Rupees 5500/- P.M.
- (2) The working hours for the incumbent shall be 6 hours per day.
- (3) A quarterly self reporting format (to be devised by the Jal Shakti Vibhag) would be filled by the Multipurpose workers & submitted to the Junior Engineer concerned. Based on this at the end of every financial year, a consolidated report would be placed (on a format to be devised by the Jal Shakti Vibhag) for the community certification of satisfactory work and conduct. This certificate shall be electronically sent to the concerned Superintending Engineer for the record.
- (4) Unsatisfactory performance may result in termination of appointment by passing an order. The process of termination shall however not be completed unless at least 3 notices have been served upon the incumbent on a specific charge and if there has been no improvement in service delivery. The concerned Junior Engineer would have to substantially put down in written the reasons for such termination and this would need to be countersigned by concerned Assistant Engineer based on record /technical reasons.
- (5) Candidate applying for Multipurpose workers shall compulsory attached detailed marks sheet of middle standard and in the event of non issuing of the same by the concerned Education Board, the detailed marks certificate from the Principal of the school needs to be attached. Evaluation criteria and short listing (if necessary) is based upon marks obtained in the Middle standard and not of any other standard even if higher qualification is obtained.
- (6) The selected candidates should be deputed/engaged on the schemes which are already outsourced to the firms/ contractors and any request for their transfer from the scheme will not be accepted at later stage.
